

KENMORE ALLIANCE CHURCH Elder Ballot for 2021

Our policy book states the following regarding the Lead Pastor: “Is accountable to the membership to maintain a life in accordance with the scriptural standard of Elder. The Lead Pastor names will appear on the annual ballot with other Elders to have this affirmed by the membership. If he receives less than two thirds affirmative vote, the Elder board and Ministry Board may call the District Superintendent to help sort out the underlying issues.”

Our Bylaws regarding the election of Elders state:

BYLAWS ARTICLE X, SECTION 1.

Elders

A. Recommendations from the congregation for the office of Elder shall be presented to the Elder Board for consideration at their September meeting. The Elders will submit a list of names to the Nominating Committee.

B. All Elders are elected by the congregation. Each person nominated for the office of Elder will be on the ballot with a yes or no next to their name. A two thirds majority of all members present at the annual meeting for elections will be needed to elect each Elder. The question is, “Does this man satisfactorily fulfill the biblical standard for the office of Elder?” If less than three Elders are elected by the congregation, then the District Superintendent may be notified.

C. The Elder Board is responsible for the vision, doctrinal purity, discipline and overall spiritual health of the church.

You are voting on if you are willing to have the following men serve Kenmore Alliance Church as Elders for the coming year? **If you vote no, you are saying that this man is spiritually unfit for the office of Elder.** You must have specific information demonstrating that the candidate is spiritually unfit. Please include your reason in the space provided and write your name at the bottom of the sheet so the Elders may investigate. *[Do not admit a charge against an elder except on the evidence of two or three witnesses. 1 Tim 5:19]*
